Commercial Plans (all)		Signed prescription needed from referring doctor. Must check back of card for pre-auth requirements
Department of Labor		Need pre-authorization for all exams. Will need diagnosis code, CPT code and claim number. Contact: 1-866-335-8319
First Health		Signed prescription needed from referring doctor. Must check authorization on each policy. Verify pre-authorization requirement on card.
GEHA		Requires pre auth from Med Solutions (888) 693-3211 for MRI, MRA, CT and Nuc Cardiac and PET scans
Humana		Most plans require pre-authorization by calling 866-825-1550 (only referring physician's office can obtain)
Kaiser	Medical Imaging Network	Must have a KAISER referral for all studies . Contact: 1-800-810-4766 If choosing to use 3-tier plan MRI's require an authorization through Permanente Advantage. (888-567-6847)
MDIPA/Optimum Choice HMO		Auth needed for all musculoskeletal MRI and CT scans. HSG for infertility. All other MRI, CT, DEXA Nuclear medicine need referral. (The only exams not requiring authorization are MRI BREAST and MRI ABDOMEN which need PCP referral)

NCPPO		Signed prescription needed from referring doctor
One Net	Formally Alliance	Check on plans for pre-authorization requirement. Call # on card.
Optimum Choice Preferred		Referral for MRI, MRA & Biopsy, pre-authorization needed for HSG w/infertility diagnosis. Pre-authorization needed for certain MRI and CT studies. Need waiver signed to use out-of-plan benefit.

PCIP		Pre-Auth through Medsolutions 866-879-8317. Use Geha guidelines for services that require pre-authorization
PHCS		Signed prescription needed from referring doctor. Some plans need pre-authorization requirements. Call # on card.
TRICARE Standard/Health NET	Formerly CHAMPUS	Signed script needed from referring doctor. Pre-operative chest X-rays and routine ob sonograms are not covered. TRICARE Prime needs referral for all exams or patient will have higher out of pocket. Contact: www.mytricare.com
TRICARE For Life/Health Net	(Also called TRICARE Prime)	Signed script needed from referring doctor. Pre-operative chest X-ray and routine ob sonograms are not covered. Must have Tricare referral for all exams Contact: www.healthnetfederal.com
United Healthcare –	Mid-Atlantic/PPP/POS	Pre-notification needed for certain groups for MRI/MRA, CT, PET and Nuclear Medicine. Contact: 1-866-889-8054 options 4, * 5, 1 and 1 or www.unitedhealthcareonline.com
Workers Compensation Plans		Call for pre-certification on all exams; need authorization #. Need employer and policy information.
